The Human Services Agency (HSA) requests approval of a sole source waiver and authorization to enter into a contract with the BlackBerry Co. for the period of August 1, 2022 through July 31, 2025, in an amount of \$772,922, plus a 10% contingency for a total amount not to exceed \$850,214. The purpose of the contract is to provide BlackBerry UEM and AtHoc Software.

#### **Background**

The Human Services Agency (HSA), Department of Homelessness and Supportive Housing (HSH), and Juvenile Probation Department (JPD) currently use BlackBerry's UEM Suite and AtHoc commercial software. HSA would like to continue the subscription services for these software licenses on behalf of the three City departments.

HSA, HSH, and JPD currently uses BlackBerry's UEM, which is an enterprise mobile management (EMM) system that provides mobile device, application, and content management and containerized mobile access to email, calendar, and contacts. HSA also uses BlackBerry AtHoc, which is a mass email and SMS notification platform.

This software and application were previously procured through the Office of Contract Administration's Tech Marketplace. HSA and the other departments would like to continue using BlackBerry but there are new requirements from the City's Department of Technology and Office of Contracts Administration. Because of the nature of Protected Health Information/Personally Identifiable Information data being shared when these services are in use, a Business Associate Addendum is required and will now have to be on a software maintenance contract agreement. Therefore, a direct contract with BlackBerry is required.

#### **Services to be Provided**

Contractor will provide access to the AtHoc commercial software and service support, and BlackBerry Spark UEM Suite commercial software and associated technical support.

#### Selection

Contractor is a sole source provider. The cloud-based software is proprietary and owned by the Contractor.

#### **Funding**

Funding for this contract is provided through a combination of Federal, State, and County General Funds.
