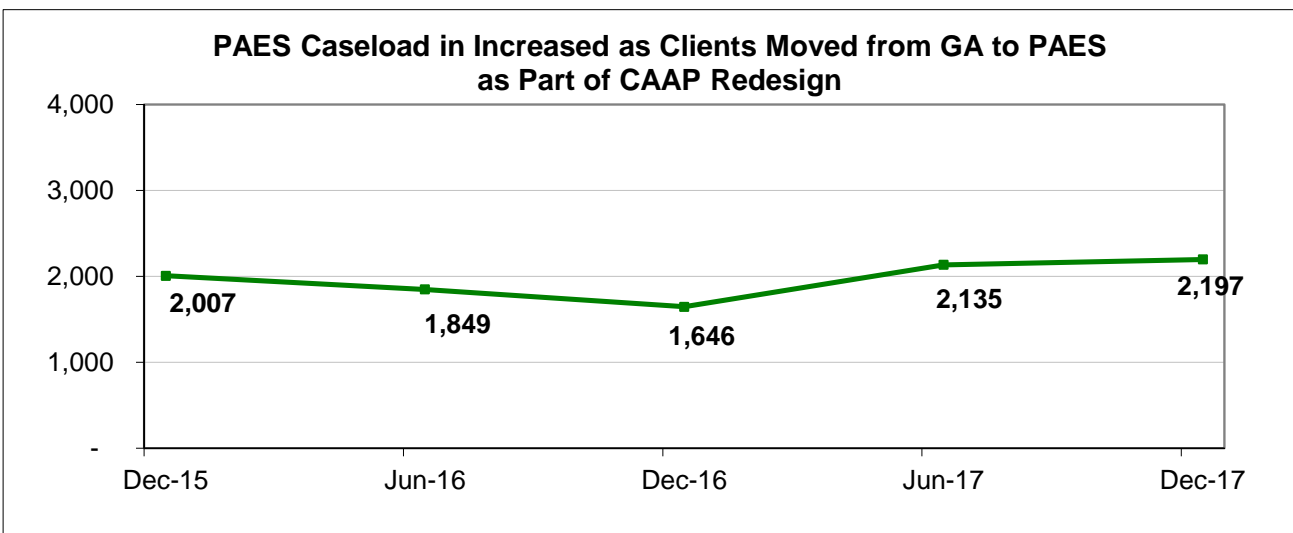
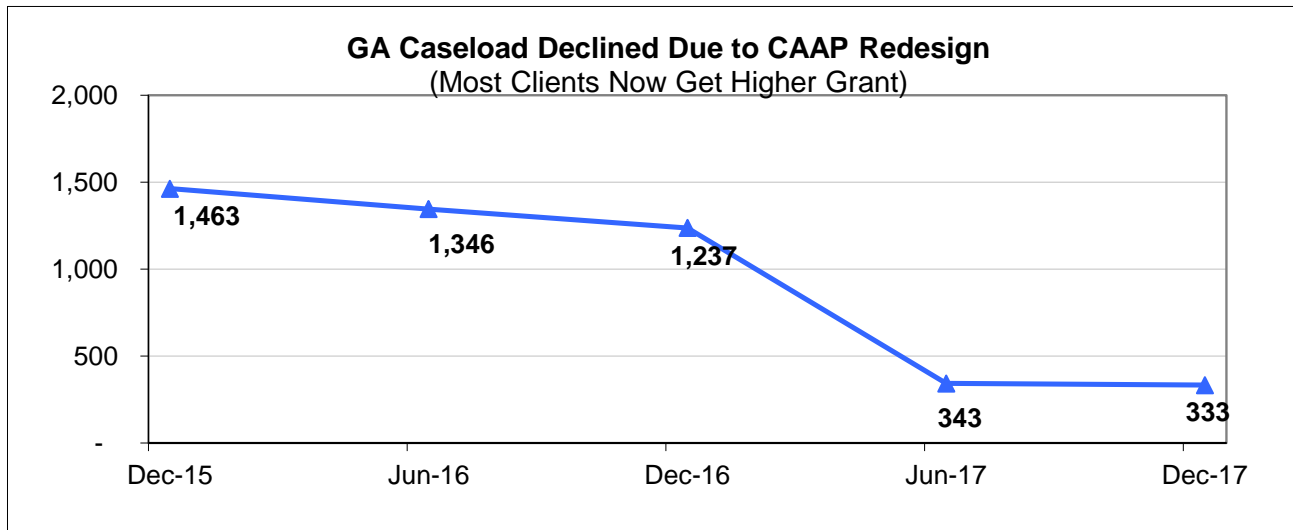
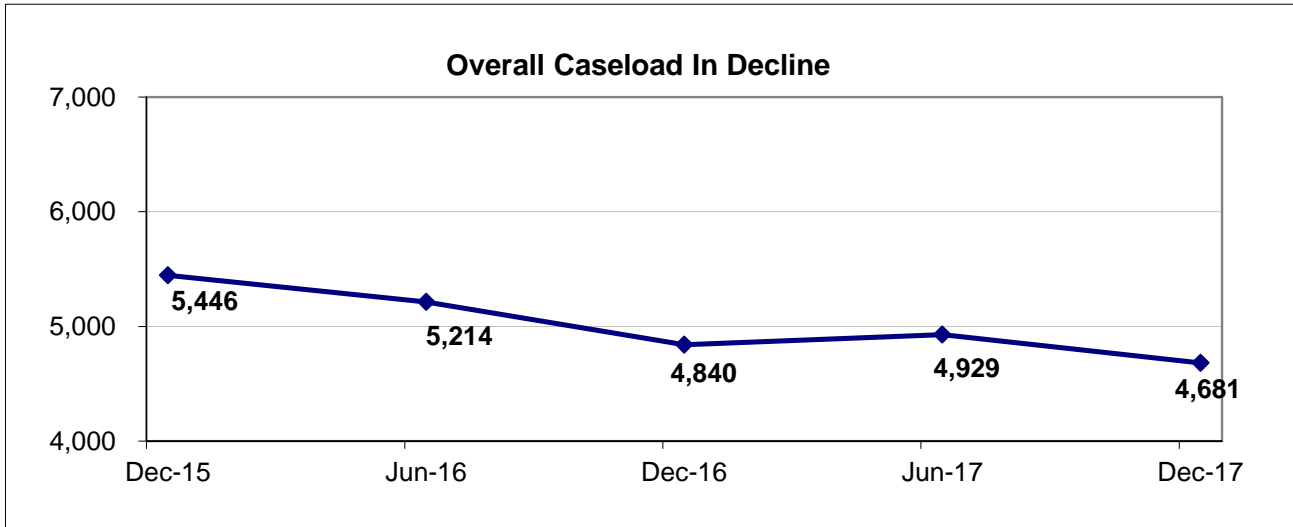
CAAP Sub-Program Breakdown



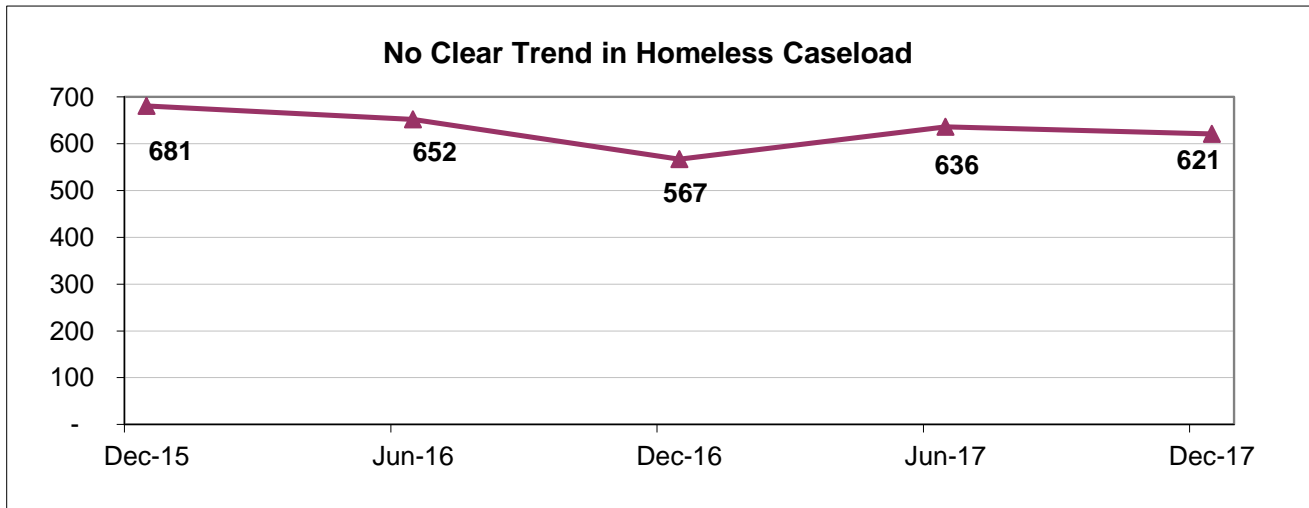
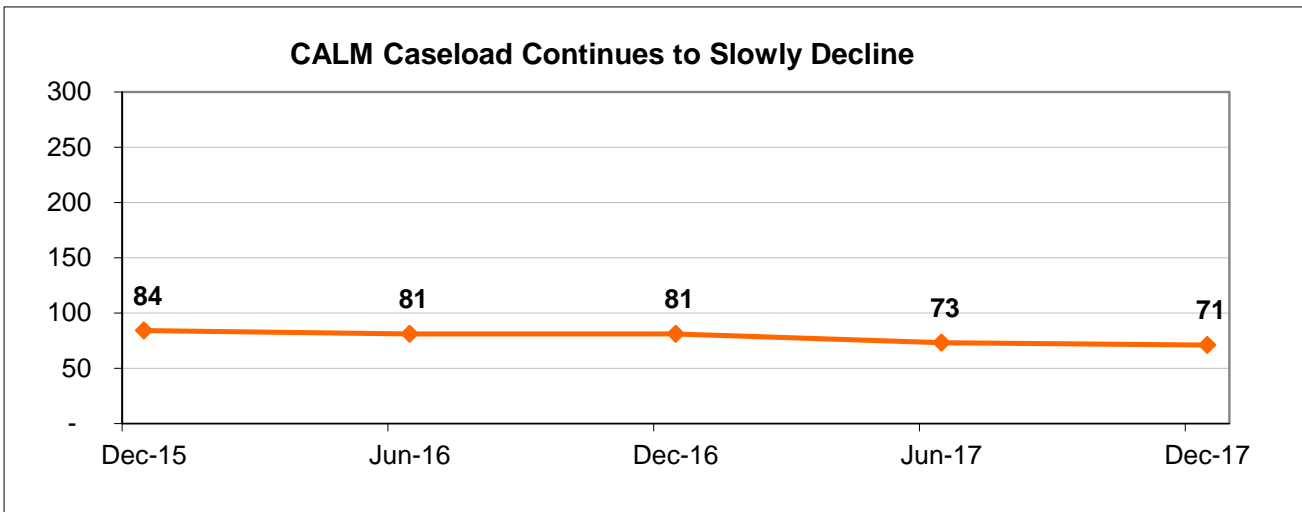
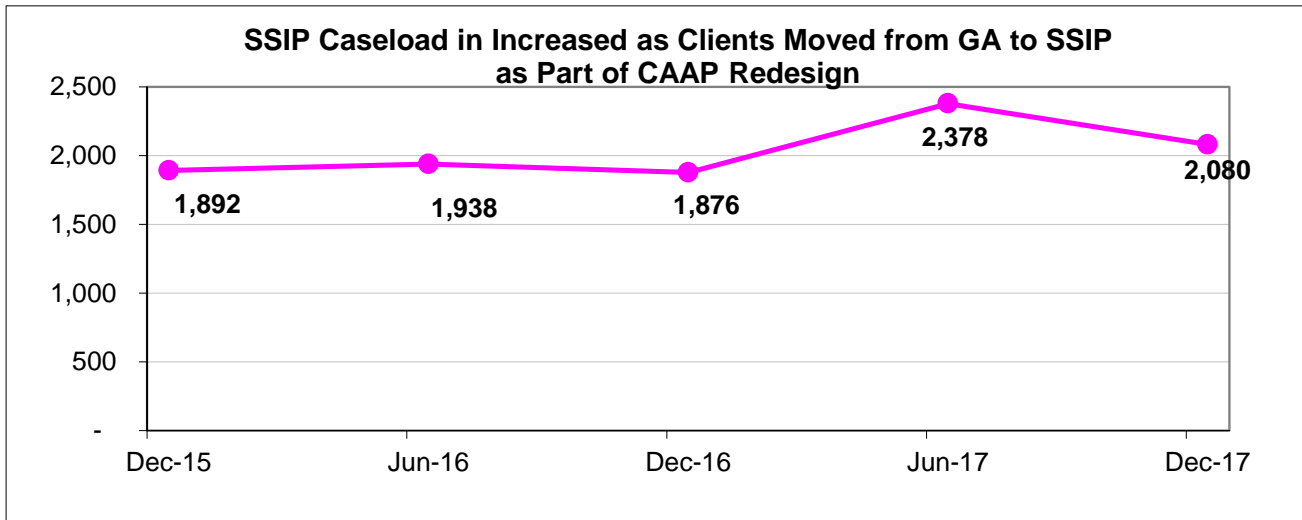
