## II. Release final ADF Action Plan 2026-2029

Presenter: Maceo Persson

- Final draft will be posted on sfhsa.org in alignment with HSA accessibility guidelines.
- Hybrid kickoff in January for deeper engagement and communication strategies among ADF members.
- Recommendations and actions were retained from August meeting.

## III. Project Updates

Outdoor Spaces and Buildings, Sunset Dunes Park

- Status: Opened April 2025; 50 acres of coastal parkland.
- Community Engagement: 2 open houses (July & Sept) + stakeholder meetings; survey open until early December.
- Feedback Highlights:



- Support for accessible entryways at Noriega & Rivera.
- Interim improvements: seating, ramps, blue zones, hammocks, bike amenities.
- Desired additions: grab bars in bathroom stalls, raised seating, beach wheelchairs, adaptive cycling, chair yoga, better signage, more blue zones.
- Bear Saver Trash Cans: Discussion on accessibility; design improvements may be considered in future phases.
- Next Steps: Technical studies through mid-2026; design phase follows.

#### Outdoor Spaces and Buildings, Hallidie Plaza – Accessible Transit Hub

- Update: Working with DPW on inclusive ramp design; biweekly project meetings.
- Recent Activity: Tour of Ed Roberts Campus for disability-inclusive design inspiration.
- Next: Updated designs to be reviewed in a second community meeting.

#### Transportation and Mobility, Wheelchair Repair Program

- Presenter: Lana Nieves (ILRCSF)
- Program Overview:
  - Open to anyone living/working in SF; repairs mostly done at ILRCSF site; loaner devices available.
  - Over 125 repairs, 20+ short-term loans, 15+ long-term loans, 30+ battery replacements.
  - Outreach: 25+ events, 8 educational videos (2,500+ views).
  - Challenges: Insurance barriers for repairs outside the home; policy advocacy needed.
- Next Steps: Develop program evaluation metrics to advocate for expansion.

#### Engagement and Inclusion, Disability Cultural District

- Presenter: Emily Beitiks
- Update: Initial city feedback suggests starting with historical signage and legacy recognition before pursuing official cultural district designation.
- Action: Clarify asks; set up meeting with key stakeholders.

#### IV. MTA Updates: Access for All Program

- Presenter: Javaun Garcia (SFMTA)
- Program Background: Supports on-demand wheelchair-accessible vehicle (WAV) services funded by TNC fees (SB 1376).
- Current Providers: Fog City Access (6 WAVs, 7 days/week), Green Cab (ramp taxi).
- Lessons Learned: Need stronger marketing and outreach; improve data collection for future funding cycles.
- Community Feedback: Service well-received; demand exceeds current capacity; outreach to seniors and underserved areas critical.





- Action: ADF members encouraged to share survey, suggest marketing opportunities, and nominate candidates for scoring panel.
