Advisory Council

- Membership Individuals and/or representatives of community organizations who can enhance the agency's leadership in developing community-based services.
 - Currently appointed by Commission (11) and Supervisors (11)
- Core Functions
 - o Guide the development and implementation of the Area Plan for aging services
 - o Represent and promote the interests of older adults and caregivers in the community.
 - Foster collaboration
 - Serve as a forum for older adults to voice needs and concerns
 - Assess local aging issues and recommend improvements to services and policies
- Purpose Serve as a community-based advisory and advocacy body that supports the mission of the AAA



Dignity Fund OAC

- Membership Structured to ensure diverse representation and expertise in aging and disability services.
 - 2 Commissioners; 3 Advisory Council; 3 LTCCC; 3 Mayoral appointment
- Core Functions
 - Ensure accountability of Dignity Fund spending
 - Advise on planning, evaluation, and funding
 - Engage the community in needs and service planning
 - Support program improvement and innovation
 - Review reports and maintain provider input
- Purpose Ensure transparent, equitable, and community-informed use of the Dignity Fund to support services for older adults and adults with disabilities in San Francisco.
