Public comment

- Allowed in person.
- Allowed remotely as a disability accommodation and must be requested in advance through the Commission Secretary.
- For each agenda item:
 - One (1) comment per person
 - Up to three (3) minutes per person
- The Sunshine Ordinance allows any person who spoke during a public comment period at a Human Services Commission meeting to supply a brief written summary of the comments to be included in the minutes if it is 150 words or less. Admin. Code § 67.16. The summary is placed as an addendum in the minutes. The Human Services Commission reserves the right to reject the summary if it exceeds the prescribed word limit or is not an accurate summary of the speaker's public comment.
- The Human Services Commission accepts written public comment via email by 5pm the day before a meeting (i.e., typically the fourth Wednesday of each month by 5pm); these comments are included in the minutes and are read aloud during the meeting, time permitting. Public comment submitted via email should be sent to: elizabeth.labarre@sfgov.org.

Remote public comment is available as a disability accommodation. If the problem cannot be resolved in a timely manner, the meeting may proceed without remote public comment.
